

The Southwest Florida Water Management District (District) purchases and manages conservation lands to protect water resources and to preserve and restore Florida ecosystems. There are more than 343,000 acres of conservation lands in the region open to the public for recreation opportunities. The 6,533-acre Serenova Tract was purchased to protect sensitive environmental areas in the western portion of Pasco County.

Designated trails provide specific nature-based experiences while minimizing impacts to the lands and natural systems. Markers identify the type of recreation available and arrows indicate the direction of the trail. Main trail intersections are numbered. See chart on back panel for latitude and longitude points that correspond to these intersections. While visiting these properties, there are certain rules and restrictions in place to protect the natural environment and to ensure a quality experience for all conservation land visitors.
